CHAPTER 35B - Geo and WERS (Continued) **Geo continues his newest duties at Headquarters**

Once initial guidelines were set up, after what seemed interminable negotiations with and between innumerable government agencies, FCC came out with a set of Rules and Regulations for the War Emergency Radio Service.

This was not an Amateur Service organization and its R & R were not a part of the Amateur Radio Regulations (Part 12). Licenses were issued to the local governments (towns, boroughs, cities or counties) under officer thereof as trustee and administered by a communications officer and a radio officer. The latter was the head honcho of the assigned WERS operations.

WERS operators had special permits, for which holder must have either commercial license or amateur operator license of any grade. All operation was restricted to band 112-115 Mc. The detailed regulations would be too wordy to include here, but from the very beginning it appeared that amateurs would do most of the organizing, operating and the building of equipment for this new civilian defense

system. So naturally the League, meaning mostly I, were heavily involved. And I was involved that is, at both a local, county, state and the federal levels.

I was not actually a leader at any of these levels. In my local Newington group the leader was Radio Aide Charlie McLeod, WIAVN. We operated under the auspices of the licensee, which was Hartford County; but I remember that a dispute arose as to whether a town or city within county could be licensed independent of county licensee.

This controversy was resolved when the FCC arbitrarily issued a WERS license to the Town of Manchester, Conn., independent of Hartford County licensee. FCC contended that the Town of Manchester had met all requirements for licensing and they had no reason not to issue the license and refused to revoke it. OCD though preferred licensing by counties but was not able to enforce this preference. As a consequence, the small cities, towns, boroughs, and the townships all over the country started taking out independent licensees...licensing picture soon became hodge podge.

The League supported OCD position, but only nominally. We took no overt action to try to persuade smaller entities to stay within their county organizations. I wrote an article or two in QST outlining advantages of county organization, but these were informational only, at the behest of OCD not intended as propaganda.

Although active at the national level through QST, and through maintaining contacts in the federal government, I participated on my own time at local level. I remember a request from the state veteran's hospital in Rocky Hill to conduct a class among this hospital's residents to enable them to qualify as WERS operators. I undertook this only with the understanding that the class would not be restricted to hospital residents or veterans. As a result we had an initial enrollment of about forty pupils, which rapidly dwindled to about twenty. Most were people who had no concept of the requirements of communicators even at the commercial third class level, but all of whom were eager to make some kind of contribution to the war effort, an attitude that was typical of the times.

I brought them to third class commercial level competence and quite above it during the six-week course of once-a-week sessions of two hours each, and we thoroughly enjoyed it. At conclusion I received a commendation from the head honcho of the hospital for my efforts. I received no pay or any other kind of compensation except my own self-satisfaction, nor had I expected any.

WERS was never put into effect, and not really a success. Of course there never was a need for a civilian defense effort in this country other than preparedness, so how it would have stood up under an actual enemy attack will never be known. In my estimation,

however, it would not have been very effective mostly because of inadequate handling at the federal level arising largely from controversy between FCC and OCD, the former being part of the congressional or legislative branch, and the latter part of the executive branch, which were often at odds with each other.

WERS continued operation until after Japanese surrender, and then was discontinued. Although largely operated by radio amateurs, it is not an amateur radio success story, principally for the reasons intimated above. Such being the case, it is just as well that it never was officially an amateur radio service.

Autobiography of W2EAG

My brother and I got interested in ham radio in 1954 when a boy my age moved next door. He already was licensed, and we were fascinated with what we saw and heard. I learned Morse Code as time went by, but did not get my Novice until I came home on leave from the Navy in May of 1959. My call was WV2FNK.

I scored very well in boot camp in electronics and Morse Code. I was sent to Radiomans' school in Norfolk, Virginia. Being that I had typing and office practice in High School, and also knew the code, I was way ahead of many in the class. I graduated 2nd and was copying about 40 wpm. After a year stationed at the Naval Communications Station, Washington D.C.(NSS), I was sent to Little Creek, Virginia to a Tactical Air Control Squadron that was attached to the Amphibious Forces. I remained there until my discharge in 1962.

During my stay in the Navy, I had little time to advance my license. In those days, the Novice was only good for a year, and I was mostly out to sea. I took the Novice over again, upgraded to Tech, then again to General. My call was WB2EAG.

I was not active for a long time as my work prevented me from doing so. I got married in 1964, Our first child was born in 1965, our second in 1969. In 1970 I started to get back on the air intermittently. I had been working in the hardware business, and painting on the side. I was waiting for my appointment as a Firefighter. It came in May of 1971. I had been living at the time, in Portchester N.Y., and was renting an apartment. My parents owned property in Dutchess County. They decided to give us a piece of the property to build on. The house was finished and we moved in July of 1972.

I had over an acre of land, lined with 75 foot trees. Ahhh, antenna supports. First antenna was an 80/40 meter dipole. Later, a tower and yagi was added, and a 160 meter loop. One day I had a QSO with a station in Mass. He asked me if I knew anything about traffic

handling. Saying no, he told me about the New England Novice Net, and invited me to join. He gave me a few pointers and explanations. I listened for about a week and took the plunge. I worked several other Novice nets for a few months until one evening I discovered NYS, the N.Y. State Section net. After about a week of listening, I decided to check in. The rest is history. I was hooked.

Through the years in New York, I wore many hats for the ARRL. I see no need to list them here. One that I am very proud of is that I founded and Managed the morning session of NYS. I was also active in ARES and RACES. I am a charter member of a club that I helped start.

In 1990 I started thinking about getting ready for retirement. My wife Sandy and I thought about moving to a warmer climate. We had been told by a ham friend of mine about New Bern, N.C. who had moved there. We visited several times and eventually bought a piece of property to build on. We moved there in 1992. We stayed for over five years. We decided to sell and move to Massachusetts to be closer to our grandchildren, that we had not seen very much of. After about 8 years, Sandy retired and wanted to move back to New Bern. We did just that.

I managed the Carolinas Net, CN for a couple of years. As of this writing, I am a member of the Eastern Area Staff, and of course have kept up my ORS appointment. I took over as Manager of the Hit and Bounce Net in 2011, and hope to continue to keep that position.

I have always loved to train others in traffic handling. I wrote a book on the subject, and am fortunate to have had it published and printed by the ARRL. Other aspects of the hobby that I enjoy are dxing, some contesting, and rag chewing. I also like experimenting with antennas. I have been accused by some, of not owning a Mic, but many of you know differently differently.

That's my story and I'm sticking to it. 73 to all.

Independent—well, sort of.

We recently celebrated Independence Day. We all know the meaning of it. HBN is an independent net, and has been since its conception. What does that mean? To me it means "away from," "free," or "not attached." In the case of HBN, unattached to the ARRL NTS, but only in a manner of speaking.

It is certainly not any kind of deterrent and does not really mean much. There are many kinds of independent nets that have been very valuable to traffic handling over the years. HBN may very well be the longest running CW independent traffic net still in existence. It is a diamond in the rough. It serves a large

area, and has generated huge amounts of traffic. Not only that, I am sure that HBN has also attracted, and helped many stations become better traffic handlers. Therefore, it is important that we keep our tradition alive, not only by our support to the net, but also by using proper net procedures to set good examples to others. Getting new members is important to any net. A strict, but friendly, well run net will do just that.

Being independent does not necessarily mean that we do not abide by the NTS rules. Mostly it means the net can run at whatever time and frequency set forth by the Manager. This actually can be an asset for the net as it can give a traffic handler an extra net to send or receive traffic.

Let us not forget that the purpose of traffic nets is to train and to keep ourselves ready for any emergency, by performing a Public Service, via Amateur Radio Communications. You might say the Public would then be dependent on us in that regard, and gives us the chance to prove our worth.

It is no secret that a net is only as good as its members. HBN is truly blessed in this regard, we have the best of the best. It is my privilege to be able to work with and be associated with all of you. Thank you for your support and dedication to a truly fine independent net. 73, ARF.


